Student Learning Outcome

Describe the specific, measurable *knowledge*, *values*, *or skills* that students will be able to demonstrate based on the Gen Ed Core Competency.

The SLO must measure what students should know, think or be able to do related to the Gen Ed Core Competency.

Outcomes must be stated with clarity and specificity, including precise verbs, rich description of the content/skill/attitudinal domain and specification of whom should be assessed (i.e., graduating seniors in the Biology BS program).

Student Learning Outcomes should be written as:

Measures

Each Student Learning Outcome must be assessed by at least two direct measures that assess the extent to which learning was achieved.

Direct measures directly assess the student learning outcome - the knowledge, skills and values students should be able to demonstrate.

They measure what students <u>have</u> <u>learned</u> and <u>to what extent learning has</u> occurred.
