- Membership in religious, professional, business, civic, or social organizations in the State of Alabama
- Maintenance in the State of Alabama of checking and savings accounts, safe deposit boxes, or investment accounts
- Alabama address shown on selective service registration, driver's license, automobile title registration, hunting and fishing licenses, insurance policies, stock and bond registrations, last will and testament, annuities, or retirement plans.

I declare, swear and affirm that the information provided above is true and accurate to the best of my knowledge and belief; that in order to be eligible for resident tuition rates, the burden of proof lies with me, and that I may be asked to provide documentation for any and all of the items that I checked above. I further understand that, if asked, my failure to provide this documentation will result in an immediate change to nonresident classification and immediate payment due for nonresident tuition for all previous semesters in which I was enrolled under resident classification.
