Approval of the minutes of the meeting of January 12, 2017.

Consideration of the request from the College of Business to change the admission requirements.

Consideration of the Request from the College of Business to clarify that MG 600 is eligible for application of the current Repeat/Recompute policy.

Dr. Paulk moved approval and Dr. Stafford seconded the motion. The motion was approved unanimously.

Consideration of the request from the Department of Management and Marketing to change the name of the 'International Business' MBA concentration to 'Global Business'. Request to add new courses: MG 632, MG 662 (Dept. of MG/MK) and BL 642 (Dept. of AC/BL). Request to change required and elective courses in this concentration.
