6. Program Design:

Brief Description of Program and Objectives:

The University of North Alabama's online Doctor of Social Work (DSW) program prepares students for the following: advanced trauma-informed social work practice and supervision, anti-oppressive social work education and training, and leadership in workforce development. The program prepares social work leaders to advocate for human rights and social/economic justice in diverse communities while incorporating the impact of global perspectives. The DSW program models a commitment to discovery and implementation of new knowledge, evidence-based research, and ethical use of technology to enhance critical thinking to promote human and community well-being while advancing community workforce development.

The DSW program will prepare the doctoral practitioner to utilize advanced theoretical frameworks in the critical application of innovative skills in the engagement, assessment, intervention, and evaluation of diverse clients and constituencies. The DSW curriculum is grounded in evidence-based research for implementation by advanced practitioners. Students will be equipped to be leaders in the fields of advanced social work practice and education. It is expected that the DSW program will take two years for the full-time student to complete (42 credit hours). Elements of the program are described after the program objectives.

Program Objectives

Graduates of this program will:

- A. Utilize advanced theoretical frameworks in the application of innovative skills in the engagement, assessment, intervention, and evaluation of diverse clients and constituencies.
- B. Demonstrate advanced social work practice skills in supervision at the agency and organizational level.
- C. Develop quantitative and qualitative research skills to address critical issues faced by vulnerable and underserved communities.
- D. Understand and implement the principles of evidence-based practice in selecting social work interventions
- E. Apply principles of social work policy practice to advanced clinical practice or organizational leadership
- F. Be prepared for faculty careers in academia

DSW COURSEWORK

The first stage of the DSW program is the major coursework. The purpose of this coursework is to prepare doctoral students in the practice areas of advanced clinical social work intervention with an integration of executive organizational leadership in workforce development as well as social work education and training. The coursework in the DSW program consists of 33 credit hours of content-focused classes as well as 9 credit hours of capstone (42 total credit hours). Coursework is facilitated online in 8-week, asynchronous sessions. Students must complete all DSW coursework (including one 3-credit hour elective in an area of interest) before scheduling their oral exam.

DSW ORAL EXAM

The second stage of the DSW program is the oral exam. The purpose of the DSW oral exam is to demonstrate advanced knowledge of required coursework as well as advanced social work theories and concepts related to advanced clinical social work practice. The oral exam serves as entrance into the doctoral candidacy phase of the program and initiation of the DSW capstone process. The oral exam will be administered through a live virtual presentation facilitated by the DSW Program Director. The oral exam will be evaluated by the 3-member doctoral committee, consisting of three approved social work faculty members (the Capstone instructor, DSW Program Director, and the DSW faculty mentor of record).

The oral exam will assess mastery of course concepts and Council of Social Work Education (CSWE) educational competencies. Students will be expected to prepare for the oral exam defense through a comprehensive review of their completed major assignments across the academic curriculum. Students will be assessed in the following areas:

- discuss mastery of course-related theory integration, assessment, evaluation, etc.;
- how these assignments provide a foundation for future advanced trauma informed social work practice;
- how the course work has prepared them for professional readiness in advanced clinical social work practice at the doctoral level;
- capstone topic of interest; and
- their professional career goals.

DSW CAPSTONE PROCESS

The third stage of the DSW program is the capstone process. The purpose of the capstone process is to develop knowledge and expertise in the student's field of practice that integrates mastery of program knowledge, skills, values, and cognitive/affective processes. The capstone is designed to incorporate components of knowledge, theory, and skills ascertained in the coursework sequence of the DSW program.

CAPSTONE STUDY PROPOSAL

The capstone proposal consists of one of the following four practice areas: a grant or policy proposal, research study, or program/curricular development. The DSW Capstone study proposal will consist of the following components:

- 1. **Capstone Seminar:** An approved project concept identification. This concept will be approved by the DSW faculty mentor of record.
- 2. **Capstone I/II:** A written proposal consisting of a literature review, relevant theory, and evidence-based research justifying their proposal concept along with the methodological approach. (The complete written capstone, including evaluation, will be approximately 25-30 pages in length.)
- 3. **Capstone III:** An oral defense of the proposal to the doctoral committee.

The capstone will be evaluated by the 3-member doctoral committee, consisting of three approved social work faculty members (the Capstone instructor, DSW Program Director, and the DSW faculty mentor of record). Upon successful completion of all required DSW program components, students will be awarded the DSW degree.

Proposed delivery format (100% in-person, 100% online, hybrid, multiple formats): All coursework will be completed online (asynchronous) with a low residency requirement. Two residency retreats (three days each) will be required. Each visit will take place during the fall semester, with options for virtual visits if necessary.

There is only one existing DSW program in the State of Alabama, at the University of Alabama. The proposed program will allow students to progress through the program quicker (two years vs. three years) and is less expensive. Additionally, we will also serve an underserved region—as UNA is uniquely situated in the northern corner of the state to serve students from north Alabama, Tennessee, and Mississippi.






