Summer 2017

April 15	•Application Deadline
Feb. 1 21- May 4	•Sudents requesting May Interesession, Regular Session, Session I & Session II courses that meet the priority April 15th deadline will be preregistered.
May 5	•Electronic Billing Statements available online.
May 8	•Electronic list of preregistered students emailed to high school counselors.
May 15	•May Interesession Begins
May 16	•Payment deadline for May Interesession. Student's schedule will be voided for failure to pay amount due. •Last Day for 100% refund of tuition and fees for May Interesession. After this date, there is no refund of tuition and fees.
May 30	•PREREGISTRATION PAYMENT DEADLINE for Regular Session, Session I & Session II. Student's schedule will be voided for failure to pay amount due.
June 1-6	• Regular Registration, Drop/Add •Sudents requesting May Interesession, Regular Session, Session I & Session II courses that did not meet the priority April 15th deadline will be registered.
June 5	•Classes Begin (Regular Session & Session I)
June 6	•PAYMENT DEADLINE for Regular Session & Session I. Student's schedule will be voided for failure to pay amount due. •Last Day for 100% refund of tuition and fees for Regular Session & Session I. After this date, there is no refund of tuition and fees. •Registration ends for Summer Session I & Regular Summer Session.
June 7	•Electronic list of registered students emailed to high school counselors.
July 3	•Classes Begin Session II
July 5	•Payment deadline for Session II. Student's schedule will be voided for failure to pay amount due. •Last Day for 100% refund of tuition and fees for Session II. After this date, there is no refund of tuition and fees.

Fall 2017

April 15	•Application Deadline
April 24-May 19	•Sudents requesting Fall courses that meet the priority April 15th deadline will be preregistered.
May 22	•Electronic list of preregistered students emailed to high school counselors.
July 11	•First Electronic Billing statement notifications sent to students UNA email address and authorized users.
Aug. 5	•PAYMENT DEADLINE PREREGISTRATION. Student's schedule will be voided for failure to pay amount due.
Aug. 11-16	•Registration and Drop/Add •Sudents requesting Fall courses that did not meet the priority April 15th deadline will be registered.
Aug. 18	•Electronic list of registered students emailed to high school counselors.
Aug. 24	•Classes Begin
Aug. 26	• PAYMENT DEADLINE FOR TUITION, FEES, ROOM & BOARD (IF APPLICABLE)
Aug. 29	•A \$50 late fee will apply to accounts with outstanding balance.
Aug. 31	•Drop/Add Ends
Sept. 7	•Final deadline for payment of outstanding account balance.
Sept. 8	•REGISTRATION SCHEDULES SUBJECT TO CANCELLATION FOR FAILURE TO PAY OUTSTANDING BALANCE IN FULL. STUDENTS WHO ARE REINSTATED WILL BE REQUIRED TO PAY THE BALANCE DUE ON THEIR ACCOUNT PLUS A \$75 REINSTATEMENT FEE.
