#### **Course Description:**

Learning experiences will focus on development of cognitive and psychomotor skills in the areas of:

A. Rhythmic reading, sight singing, dictation, and other aural and written skills. Melodic performance skills will include: chromatic nonharmonic tones; such as the secondary dominant; various forms of modulation; diatonic modes; symmetrical scales (such as whole tone and octatonic scales); atonal harmony; divisions of simple and compound meter; borrowed meter, odd meter, and syncopation.

B. Dictation skills will include various rhythmic patterns, including divisions of simple and compound meter; syncopated rhythms, odd meters, hemiola and harmonic dictation increasing in difficulty from major/minor tonality to chromatic exercises.

## **Course Objectives:**

The student will learn to use the harmonic musical alphabet in regard to both notation and rhythm.

- A. The student will learn to hear, to vocally place, and to notate diatonic, chromatic, and modal harmonies.
- B. The student will learn about twelve-tone methods and patterns.
- C. The student will learn to use simple, compound, and changing meter patterns
