All initial candidates complete three courses or nine hours that have as their only focus helping the candidates understand their roles and responsibilities as the primary classroom teacher for students with disabilities. These courses include: an introductory or survey course where the emphasis is on characteristics and eligibility for services; a classroom management course that focuses on theory and application of management strategies and applied behavior analysis; and a course where candidates study research-based accommodations and modifications to ensure they have the skills to teach students with disabilities who may be in the P-6 classroom. Throughout the elementary education program, initial candidates are taught strategies to assist them in all core content areas, as well as assessment and assistive technology. In the undergraduate elementary and secondary education programs, all teacher candidates take courses which have components that focus on working with culturally and linguistically diverse students. These courses have the teacher candidates create activities and lesson plans where the needs of English language learners are met. At the elementary level, the primary course for this is Teaching the Language Arts. At the secondary level, the two primary courses for this are Materials and Methods of High School Teaching and Principles of High School Education.
