SPECIFICATIONS:

The University of North Alabama is seeking bids for the move of Dr. Chunsheng Zhang (*Pronounced "Trin-Shung Jong"*) currently resident at 3365 South Lambert Street, Eugene, OR 97405 to Florence, Alabama 35632 the last week of February 2009.

It is the responsibility of the bidder to contact Dr. Zhang (Cell# 541-543-6971 or Home# 541-991-4919) to make arrangements to receive estimate information needed to complete this bid. It is recommended, not required, that a site visit occur to facilitate an accurate bid, or proposal.

All items will require packing and will move at one time. A portion will be delivered to a temporary residence on or near UNA campus and the remaining items will need to be stored until a permanent residence is located. At that time the stored items as well as the items at the temporary location must be moved to the permanent residence.

Proposal should include:

- Total cost of initial move from Oregon to Florence; to include initial packing, delivery of a portion of the packed items to a temporary location on or very near UNA Campus; and the remainder to a storage location.
- Monthly cost of storage (include details regarding insurance and type of storage)
- Estimate of final move to include re-packing of items delivered to the temporary location and delivery of all items to a permanent location. Assume distance by quoting within a 10, 15, 25 & 50 mile radius or by mile.
- Details of liability insurance; storage coverage; breakage, and any other items covered.

Bid Evaluation will include total cost; storage capability; availability and ability to guarantee quote based on known factors involved in the move.
