- 2. All bidders shall base their proposals on the exact schedule of equipment, material or service specifications herein.
- 3. Pictures, descriptions, and specifications should accompany all bids when required or desirable. Samples may be required and, if so, shall be furnished free of cost to the Owner.
- 4. Reference to manufacturers, suppliers, catalog numbers, etc., is intended to set quality standards and does not preclude bids from others as long as quality standards are met. Offers of equal items shall state the brand and number or level of quality. Alternates will not be considered unless they conform to the specifications.
- 5. All bidders are required to submit unit prices and extended prices, where applicable, for each item bid. Where the unit price and the extended total price do not agree, the unit price shall prevail.

The University of North Alabama is seeking bids for the supply of approximately two (2) new Ford F650 / Starcraft XLT 44 passenger buses 2011 or newer. The University intends to buy two (2) buses with the option to buy more if required or if appropriated budget is available. No guarantee is made that any quantity will be purchased as a result of this bid.

Qualified bidders must be factory authorized dealers for the Starcraft XLT quoted. All maintenance service must be local and provided by factory trained service personnel. Proof of authorized dealership may be requested and must be made available within 48 hours of the request.

All fees, title and other, are to be paid by the vendor. Vehicle Title issued as the result of this bid award and purchase will be listed in the name of University of North Alabama, University Fleet, 1660 Tune Avenue, Florence, AL 35630.

The lowest responsible bidder will be determined by the most cost efficient solution meeting all needs and requirements noted and intended by the University in the issuance of this bid document. The award factors of this bid will be based equally upon the following parameters: Overall pricing, Amenities, Delivery, Maintenance & Serviceability options. For consideration, bidders must supply a complete bid package to include: signed copies of the bid document; full warranty details; clearly documented maintenance plan; delivery commitment; and itemized quote featuring full details of the amenities included in the delivered price quoted.

The winning bidder will be required to deliver the bus to the University of North Alabama bus garage, located at 1660 Tune Ave, Florence, AL 35630, for inspection prior to any alterations, wrapping or other changes. If bus is found unacceptable based on the bid specifications and quote accepted, the University reserves the right to disqualify the vendor and award to the next lowest responsible bidder.

Vehicle offered for purchase must be **NEW** and the specified make & model or equivalent. No used, remanufactured or irregular product will be considered for purchase <u>Bidder must comply with all specifications in order for the bid to be considered responsive or responsible. Basic General Technical specifications published by the manufacturer will not be accepted. Bidders must submit with the bid a detailed description of all accessories and equipment included in the bid. All accessories described must meet or exceed listed specifications.
