The University reserves the right to reject any and all items of any and all bids and to waive informalities. Bids will be awarded by item number and total lot.

DETAILS

Payment must be in cash or certified funds (i.e. money order, etc.) Bidder will provide all moving equipment and personnel needed for dismantling and removal from University property. There will be no cost to the University in removal or moving of equipment. Bids will be opened in the Purchasing Office, Room 126, Bibb Graves Hall, University of North Alabama, Florence, Alabama at 1:00pm local time on Wednesday, December 10, 2014. Winning bidders not present will be notified by email or phone. Winning bidders must pay for item and provide a receipt to the purchasing office to remove their items.

Bid Close: All bids must be received in the Procurement Office, Bibb Graves, Room 126 by 1:00PM on Tuesday, December 16, 2014. All bids will be read aloud in a public forum. Formal results to include tabulation and award announcement will be published within 72 hours to all bidders through an email notification. All files will remain on open record for inspection within the Office of Procurement.

Bid Award: The award will go to the highest qualified bidder.

Payment: The winning bidder will pay 100% of bid award price to the University of North Alabama by cashier's check, certified check, or in U.S. Currency **prior to** the removal of any property. Items must be paid in full by 4:00pm on January 8, 2015. Payment will only be accepted at the Cashier's window in the Basement of Bibb Graves and a copy of the receipt delivered to the purchasing office (room 126 Bibb Graves).

Removal Process: The winning bidder must remove all equipment from UNA's property within 8 business days after the bid due date, which is January 8, 2015. All activity related to the removal of equipment must be coordinated through Mike Thompson in the Facilities Department. If items are not paid for and removed by this date, we will assume bid has been abandoned. Note: Due to the closure of the University, no items can be removed after 4:00 p.m. on Thursday, December 18 through Sunday, January 4. Items not picked up before the University closing will need to be scheduled for pick up upon the re-opening of the University on Monday, January 5, 2015.
