The University of North Alabama is seeking proposals for insurance coverage of the items listed herein. Most are vehicles, while some items are actually off-road equipment. We are requesting full coverage on some of the vehicles and will assume only liability coverage on the balance. The university is OPEN to recommendations on coverage and what might best suit a university environment. The majority of vehicles and equipment have one or a few assigned, licensed users; however some of the automobiles (typically Crown Victoria's) and three of the E350 vans (back seat removed – 12 passenger) are in an open motor pool available for any University licensed driver to operate. The University also requires reasonable coverage for Rented Vehicles while being driven by employees on university business.

NOTE: The purchase price listed for the equipment items obviously do not represent the current value of these items, however we must assume this to be represent an assumed replacement value. University expectation is a recommendation of coverage options for these items.

Selection will be made based on the most qualified provider(s). The university reserves the right to determine the best solution at its sole discretion. Award may be made to one or more providers dependent upon the best overall solution.
