# INSTRUCTIONS TO BIDDERS

- 1. All bidders are to submit bids on proposal forms furnished by the Associate Vice President of Business and Financial Affairs, University of North Alabama (forms enclosed). All bid forms are to be signed in all designated spaces by an authorized officer or employee of the bidder. Telephone bids will not be accepted. Bids submitted by "fax" machine will not be accepted. All bids are to be mailed or delivered in a sealed envelope.
- 2. All bidders shall base their proposals on the full scope of service specifications herein.
- The Owner reserves the right to reject any and all bids and to waive informalities. Any discrepancies observed upon opening bids shall be publicly noted at that time.
- 4. All prices submitted on the proposal are to be all inclusive for work performed and shall not include any state or local sales tax. Submission of a completed DCM Form C-3A: Accounting of Sales Tax is required.
- 5. Bidders should sign & return all pages of the complete bid to imply complete understanding and compliance with all bid requirements.
- 6. Should a bidder find discrepancies in, or omissions from the bid documents or should such bidder be in doubt as to their meaning, the bidder should at once notify the Owner who will send written instructions to all potential bidders.
- 7. Bids received after the bid opening date and time, or any authorized postponement thereof, will not be considered.
- 8. A bid security must be furnished with all bids in excess of \$50,000.00. The bid security shall be in the form of a bid bond (executed by a surety company duly authorized and qualified to make such bonds in Alabama) or a cashier's check (drawn on an Alabama bank) payable to the Owner. The amount of the bid security must be no less than 5% of the contractor's bid, not to exceed \$10,000.00. If a bid bond is furnished in lieu of a cashier's check, DCM Form C-4, Form of Bid Bond, is to be used.
- 9. Title 34, Chapter 8, <u>Code of Alabama, 1975</u>, required licensing for general contracting when the cost of work exceeds an amount established by the State Licensing Board for General Contractors. All bidders must show evidence of this license before bidding. Therefore, the outside of the sealed bid must bear the bidder's name and state license number for general contracting.
- 10. Upon bid award, Contractor will provide Certificate of Insurance naming the University of North Alabama as additionally insured for the duration of the project.
- 11. 

# REQUIREMENTS/ SPECIFICATIONS

#### Overview:

The University of North Alabama is seeking licensed contractors for the demolition of the Math Building located within the main campus at One Harrison Plaza, Florence, Alabama. The process requires a controlled demolition, appropriate disposal of all waste, and site refurbishment and clean-up capable of supporting new construction and landscaping.

This building resides within the heart of an active campus requiring prudent management of dust, debris, and process controls. The awarded contractor will be required to follow all University Policies and Procedures while on campus and personnel will be restricted to approved access areas.

Time is of the essence; all work will be coordinated with the University Facilities Department with the expectation of commitment to timeline. Once the timeline is established between the Owner and Contractor, the Contractor will be considered in default if unable to sustain the approved timeline. The Owner reserves the right to adjust the timeline if appropriate or necessary, but retains full authority to dismiss a contractor for unapproved slips in the schedule.

## **Scope of Work:**

Demolition of Math Building, first and second floor framed structure with brick veneer. Demolition to include adjacent sidewalks, covered walkways, garages including floor slabs, all mechanical and electrical equipment and any other detail provided at the pre-bid meeting not specifically noted here.

Existing basement wall to be left in place.

All debris to be removed and appropriately discarded in an approved manner. Site to be restored to green field quality fully ready for new construction.

One on-site pre-bid meeting to evaluate and answer questions publicly will occur. **All potential bidders must attend**. Any notes from the meeting will be documented and published to all bidders in attendance.
