1. All bidders are to submit bids on proposal forms furnished by the Associate Vice President of Business and Financial Affairs, University of North Alabama (forms enclosed). All bid forms are to be signed in all designated spaces by an authorized officer or employee of the bidder. Telephone bids will not be accepted. Bids submitted by "fax" machine will not be accepted. All bids are to be mailed or delivered in a sealed envelope.
2. All bidders shall base their proposals on the full scope of service specifications herein.
- 3.. The Owner reserves the right to reject any and all bids and to waive informalities. Any discrepancies observed upon opening bids shall be publicly noted at that time.
4. All prices submitted on the proposal are to be all inclusive for work performed and shall not include any state or local sales tax. **Submission of a completed DCM Form C-3A: Accounting of Sales Tax is required.**
5. Bidders should sign & return all pages of the complete bid to imply complete understanding and compliance with all bid requirements.
6. Should a bidder find discrepancies in, or omissions from the bid documents or should such bidder be in doubt as to their meaning, the bidder should at once notify the Owner who will send written instructions to all potential bidders.
7. Bids received after the bid opening date and time, or any authorized postponement thereof, will not be considered.
