INSTRUCTIONS TO BIDDERS

- 1. All bidders are to submit bids on proposal forms furnished by the Associate Vice President of Business and Financial Affairs, University of North Alabama (forms enclosed). All bid forms are to be signed in all designated spaces by an authorized officer or employee of the bidder. Telephone bids will not be accepted. Bids submitted by "fax" machine will not be accepted. All bids are to be mailed or delivered in a sealed envelope.
- 2. All bidders shall base their proposals on the full scope of service specifications herein.
- The Owner reserves the right to reject any and all bids and to waive informalities. Any discrepancies observed upon opening bids shall be publicly noted at that time.
- 4. All prices submitted on the proposal are to be all inclusive for work performed and shall not include any state or local sales tax. Submission of a completed DCM Form C-3A: Accounting of Sales Tax is required.
- 5. Bidders should sign & return all pages of the complete bid to imply complete understanding and compliance with all bid requirements.
- 6. Should a bidder find discrepancies in, or omissions from the bid documents or should such bidder be in doubt as to their meaning, the bidder should at once notify the Owner who will send written instructions to all potential bidders.
- 7. Bids received after the bid opening date and time, or any authorized postponement thereof, will not be considered.
- 8. A bid security must be furnished with all bids in excess of \$50,000.00. The bid security shall be in the form of a bid bond (executed by a surety company duly authorized and qualified to make such bonds in Alabama) or a cashier's check (drawn on an Alabama bank) payable to the Owner. The amount of the bid security must be no less than 5% of the contractor's bid, not to exceed \$10,000.00. If a bid bond is furnished in lieu of a cashier's check, DCM Form C-4, Form of Bid Bond, is to be used.
- 9. Title 34, Chapter 8, <u>Code of Alabama, 1975</u>, required licensing for general contracting when the cost of work exceeds an amount established by the State Licensing Board for General Contractors. All bidders must show evidence of this license before bidding.

 Therefore, the outside of the sealed bid must bear the bidder's name and state license number for general contracting.
- 10. Upon bid award, Contractor will provide Certificate of Insurance naming the University of North Alabama as additionally insured for the duration of the project.
- 11. REQUIREMENTS/ SPECIFICATIONS

Overview:

The University of North Alabama is seeking licensed contractors to make exterior structural repairs to Flowers Hall located at 701 N Pine St, Florence, AL 35630. The project scope includes repairing all spalled concrete areas and cracking on the building exterior columns and pedestrian bridges with specified materials and applying a concrete coating.

Time is of the essence; all work will be coordinated with the University Facilities Department with the expectation to commitment to timeline.

Scope of Work: Per Flowers Hall Exterior Structural Repairs construction documents prepared by Smith Seckman Reid, Inc. (Project No. 23640100) dated May, 2023. The work generally includes:

- Structural repairs to spalled concrete areas on exterior columns and two pedestrian bridges
- Provide all equipment and temporary bracing needed to perform repairs safely
- Apply a concrete coating after repairs
- Coordinate all work and schedule with a representative of UNA Facilities
- Site clean up


