All heavy equipment must be operated by licensed operators and be covered by appropriate liability and workman's compensation insurance. Evidence of current licenses and insurance will be required prior to the start of work on site.

General Scope of Work:

Retrofit digits and team names; Re-paint and re-letter scoreboard; Removal of screen with replacement of panel for advertising, new Federal Horn, new 25 second clocks and Wireless Remote Control System installed.

Amber type double stroke; super-bright, wide angle

Painting the scoreboard:

We would like the scoreboard to be painted black with white trim and white lettering. The paint would need to be a weather proof or all weather type of paint.

Upgrades:

New 25 Second Clocks should be installed and the old clocks removed. A Wireless Remote System is to be installed for total scoreboard and clock operation. A new Federal Horn should also be installed.
