I. Executive Summary

Dr. Lisa Clayton served as Committee Chair for 2013-14 and Dr. Miranda Bowie is expected to serve as chair for the 2014-15 academic year. During 2013-14, the Athletics Committee continued the NCAA Division-I Work Group. With the Division-I Work Group, a working body within the Athletics Committee, the strategic tasks of the Athletics Committee have been evenly divided between the work group, the Gender Equity Sub-Committee, and the Minority Opportunity Sub-Committee. These three groups ensure that the athletics program is compliant with regard to NCAA, Gulf South Conference, state and federal law procedures, as well as gender equity and minority opportunities. The NCAA Division-I Work Group appointed Mr. Mark Linder as chair, and continued focusing on gaining a thorough understanding of the workgroup's mission and the knowledge that is necessary to complete said mission. The Gender Equity Sub-Committee continued working toward the Strategic Plan. The Minority Opportunity Sub-Committee continued the Minority Student Athlete Mentoring Program. Christa Raney and Daryl Brown served as Chairs of the Minority Opportunity Mentoring Program. In addition to the work of the subcommittees, the Athletics Committee focused discussions on the welfare of student athletes, particularly in the areas of budget concerns that effect student-athlete scholarships and appropriate accommodations.

- 7. Oversee all programs designed to ensure the academic success, personal development and personal welfare of student-athletes
- 8. Handle all proposals affecting University policy according to section C.2 "Shared Governance Procedure for Policy Change Recommendations"
- 9. To submit a final written report electronically by the first contract day of the academic year to the President with a copy sent to the Chair of the Shared Governance Executive Committee

VI. Athletic Director Report

- The Weight room is in progress of being built.
- In the near future, an Academic Resource Center for student athletes will be in the Self Field House.
- A brochure that was mailed to the OVC presidents in January 2014 was viewed by the Athletics Committee members. The brochure included the University of North Alabama Athletic Department strategic plan, timeline, geographic fit, academics, student athlete welfare, and facilities information. Once an invitation is secured from the OVC, another publication of the brochure will be mailed to the UNA stakeholders. The OVC will meet again in late May 2014.
- House Bill of 424 was passed in May 2013. At the time of registration, a full-time undergraduate student enrolled at an institution whose Board of Trustees has authorized resident tuition rates to apply to those non-resident students receiving a partial or full scholarship award in recognition of a particular talent or ability, provided each student possessed the talent or ability at the time of initial enrollment and maintains continuous scholarship eligibility at that institution. The bill has potential benefits for UNA. The UNA Board of Trustees will receive the bill at the June or September 2014 meeting. The parameters of the bill are established by the institutions.
- Division I work group meetings will be set up once an invitation has been received from the OVC.
- The GSC hired Matt Wilson as the new commissioner.

B. In future years?

- a) The Committee will continue to assist the Athletic Department in working toward Gender and Minority equity in order to ensure continued progress in these areas as required by the NCAA.
- b) The Committee will continue to work with the Division I Work Group to assist in the transition from NCAA Division II to Division I Athletics at the University of North Alabama

VII. What are the Committee's weaknesses?

The committee spends much time discussing how to better the personal welfare and development of the University of North Alabama student athletes. The topics discussed most thoroughly this year included, budget concerns that effect student-athlete scholarships; adequate accommodations particular for female student-athletes; and the increased travel time that is occurring with the Gulf South Conference schedule and the effects of missed class time by the student athletes. The committee has been in agreement that actions are necessary to improve these situations to ensure

the welfare of the UNA student athletes; however, very few formal charges have been proposed or taken. In addition, student participation in committee meetings has increased in the past year; however, continues to be sporadic.
