- In February 2015, Mark Linder will meet with the UNA Deans and the Faculty Senate to discuss submitting grades electronically.
- UNA Athletics will host the GSC 2015 Cross Country meet in Moulton, AL. The date is set for October 24, 2015.
- UNA Athletics will host the GSC 2016 Golf Tournament for Men and Women on April 18-19, 2016.
- The annual GSC meeting for financial aid, registrar and sports information is scheduled for May 27-28, 2015 in Birmingham, AL.
- The NCAA Convention is scheduled for January 15-18, 2015.
