The Athletics Committee met on September 12, 2016, October 17, 2016, December 1, 2016, January 23, 2017, March 15, 2017, and April 26, 2017

- IV. What were the Committee's actions and accomplishments this year relative to each of the items of the charge?
 - As the Chair of the Minority Opportunity subcommittee, Christa Raney met with the Minority Opportunity Committee on November 29, 2016 to review the strategic plan and to discuss the mentoring program. The mentees in the Minority Student-Athlete Mentoring program are chosen by their coaches. Christa plans to create a survey for mentees in the mentoring program in order to improve the program. (Charge #1, #2, #6, #7)
 - As the Chair of the Gender Equity subcommittee, Debbie Williams met with the Gender Equity Committee on February 23, 2017 to go over the strategic plan. The committee was asked to compare salaries of assistant female coaches in the GSC and other Division II schools. The Gender Equity Committee voted unanimously to recommend to the Athletics Committee to review the salary survey and base the salaries of assistant coaches by years of experience. Mr. Evan Thornton brought forth a motion to make a request that Human Resources do an in-depth

study of our assistant coaches salaries compared to peer institutions. The athletic committee supports the recommendation of Human Resources. (Charge # 2, #3) Athletics Committee position – SUPPORT

- Pat Roden the FAR discussed with the Athletic Committee how to create more student involvement with faculty and staff. Focusing on building relationships between academics and athletics (Charge #1, #2)
 UNA Athletic sports golf and softball were selected to participate in a NCAA survey- survey due on May 5, 2017. (Charge #2, #3, #4, #5)
- Athletic Director, Mark Linder discussed how the UNAConnect1 program launched on September 13, 2016. The program is designed to encourage face to face interaction and build interpersonal relationships. (Charge #1, #5, #7)

 - The Athletics committee recommended a mentoring program for international student-athletes
 - The Athletics committee recommended an increase in stipend for Graduate Assistants in the Athletics Department from \$600 to \$1,000 per month.
