## **Old Business:**

1. Working Group membership was approved, and all nominees accepted. The members are:

- 2. Study Abroad Faculty Trip Proposal Form: The revised form was used by the current trip leaders. C Christy stated that the IAO needs a clean copy to include on the website.
- 3. Trips Approved for 2013-14: there was discussion of the approved trips for 2013-14. It was noted that although the culinary trip to Peru has not been officially approved, there were several students connected with it who had applied for travel scholarships. The committee decided to consider the applications for approval anyway, with the anticipation that the study abroad trip would take place, and with the understanding that the money would not be distributed if the course did not make.

4. Draft of Study Abroad Rationale: J. Bibbee presented a study abroad rationale for consideration of adoption. After discussion and suggested changes, the committee voted to accept the rationale for posting on the Advancement Office website. Jeffrey will email a final copy to committee members.

## **New Business:**

1. Decisions on Study Abroad Scholarships for the First Round (67 applicants): D. Dodson listed concerns of applications that needed to be considered. These included essays less than the minimum 500 words, applications of students returning to a home country and the stated purposes, and essays that were of minimal quality in structure. After discussion, committee stated that there would be a need to communicate with trip leaders that if a student is traveling to home country to see family, then will not consider application. If invited to go to assist the team, as in translator, then that needs to be clarified as such. After much discussion, the motion was made by Claudia Vance and seconded by Dan Hendricks, to accept the applications of 61 applicants, with 6 applications being denied for various reasons. One had no attached essay, one had insufficient words in the essay, and four others denied for other reasons. Depending on the reasons, the students will be encouraged to reapply in the second round. One student had not contacted any trip leader prior to applying, and will be encouraged to do so before the next round. The motion was passed unanimously.

Jeffrey Bibbee expressed the need to consider how to separate funds for Magellan applicants since there really needs to be more money for a semester of study abroad.

- 2. Dan Hendricks shared about potential donors for the study abroad funds.
- 3. Craig Christy stated that there has been a significant increase interest in the Magellan program, as well as an increase in the number interested in non-UNA sponsored study abroad programs.
- 4. Craig Christy and Jeffrey Bibbee reported that the Study Abroad Fair at Alabama A&M had a modest turnout, and that there seemed to be real interest shown.
