### ANNUAL REPORT 2022-2023

#### I. Executive Summary

The University Research Committee released the 2022-2023 grant application in October 2022, completed applications were due in January 2023. The committee met on February 10<sup>th</sup>, 2023 to review grant proposals and vote on funding awards. 15 projects with a total budget of \$32,566 were eventually funded.

  - 6. To submit a final written report electronically by the first day of the fall semester to the Provost and Executive Vice President for Academic Affairs with a copy sent to the Chair of the SGEC

IV. What were the Committee's actions and accomplishments this year relative to each of the items of the charge?

This year, 15 project proposals from 13 departments and three colleges were funded through the University Research Committee with a total fund of \$32,566. Two additional projects were initially funded but withdrawn by the PIs.

V. What were the Committee's formal recommendations?

After careful evaluation, the committee recommended partially or fully funding 17 projects out of 20 submitted proposals for various activities such as research projects and creative artworks. Two awarded grants were withdrawn later.
