- I. Call meeting to order Senate President, Jarrod Russell, called the meeting to order at 10:00 a.m.
- II. Guest speaker Evan Thornton spoke to the Staff Senate regarding proposed changes to the tuition remission policy. The changes he outlined were as follows:
 - a. If an employee or retiree dies while in service, their dependents will receive tuition remission.
 - b. Students have to choose either tuition remission or scholarship, they cannot use both.
 - c. Summer tuition will not be paid for dependents.

- IV. Approval of minutes Ms. Bolton made a motion to approve the minutes from the April 9, 2018 meeting as printed. Mr. Banks seconded and the motion carried.
- V. Approval of agenda Mr. Alexander asked that Strategic Plan Steering Committee Open Forums and Non-exempt employee time clock App be added under Discussions Dr. Jacques made a motion to approve the agenda for the May 14, 2018 meeting as amended. Ms. Bolton seconded and the motion carried.
- VI. Staff Senate President's report

This was a decision by the Executive Council to encourage employees to read the Digest. Dr. Kitts will ask the council to send bereavement notices separately, but job postings will remain in the Digest.

 - g. The Online Advisory Committee was dissolved.

 - iii. The Senate would like to have tuition remission available after the 90 day probationary period.
- b. Consensual Relationship Policy
 - i. The Senate did not vote on this in November.
 - ii. There are revisions to be made, and Staff Senate will wait and vote on final policy.
 - iii. A definition for graduate student needs to be added.
- c. Staff Attitudes Survey 2018
 - i. The surveys were distributed for senators to read. A meeting will be held later to discuss.
