XIII. OLD BUSINESS

- Alma Mater
  - Chairwoman McDonald thinks we should write a resolution to change it and offer suggestions.
  - There is a Shoals Music society that could help with this.
  - Senator Anthony says it would be great to have a group of SGA members gather information for this before a resolution.
  - Senator Lachowicz says that the university can come out with a statement to say we do not condone any discrimination against anyone.
  - Communications Director Mwaura suggests that we use the information that was gathered last year.
  - Treasurer Hanback says he would love to see more UNA specific language included in the alma mater.
  - Communications Director Mwaura says this could be a great thing to partner with the rebranding.
  - There is a Muscle Shoals heritage museum that is connected to UNA. That would be a good place to start.
  - President Rhoades can form an ad hoc committee for this.
  - Senator Moore believes that if we try to change it that it may bring more problems than it would solve.
  - Historian Holcomb says that an ad hoc should be formed.

- Chief of Staff Thomas also says that an ad hoc committee should be formed but there is also a lot of research already started.
- The UNA band changed their name because it had the word “dixie” in it.

#### XIV. NEW BUSINESS

- Bill 26-01: No Contact Bill
  - This is to focus more on group efforts like attending Florence City Council meetings, Higher Ed day and SLUAC.
  - Chairwoman McDonald gives more information as to why they are changing this. It is hard to get in touch with different representatives. They can get with representatives better with the Higher Education partnership.
  - Senator Moore asks if there is a requirement in the Code of Laws about attending city council meetings and there is.
  - Senator Sharma asks if they would lose anything if we did not send letters, and the author of the bill says she is not sure but having this bill does not state that they do not have the ability to.
  - The bill passes.
- Bill 26-01: Valentines Mixer Funding Bill
  - Senator Huffman asks if there were more than 50 people, and people said there were not more than 50 people last year.
  - There was an amendment on the floor to change the total to \$325. The amendment was passed.
  - The bill passes with the amendment.
- Voting on mandatory 5K date
  - The date for the 5K is March 7<sup>th</sup>. The rain date is March 28<sup>th</sup>.
  - The time frame for this would be 7 AM to 1 PM.
  - The 5K is now mandatory.
